<p>Step 1: Receive the Letter and find the official church name and account number information</p>	
<p>Step 2: visit website Sos.nebraska.gov/report Choose the “Domestic and Foreign Nonprofit Corporations biennial reports are due in the odd numbered years by April 1, delinquent June 2.” File Now Online link</p>	
<p>Step 3: Enter the Church account number from the yellow cardstock letter.</p>	

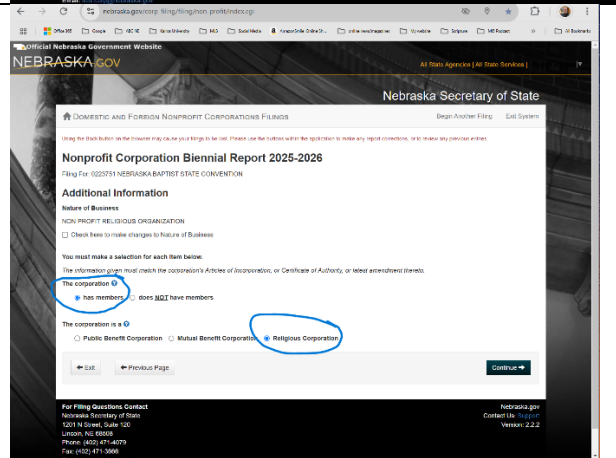

Step 4: Confirm the official church address and name. If it is correct, choose continue.

If you need to update the address, choose the “Check here to make changes to the Principle Office Address” button.



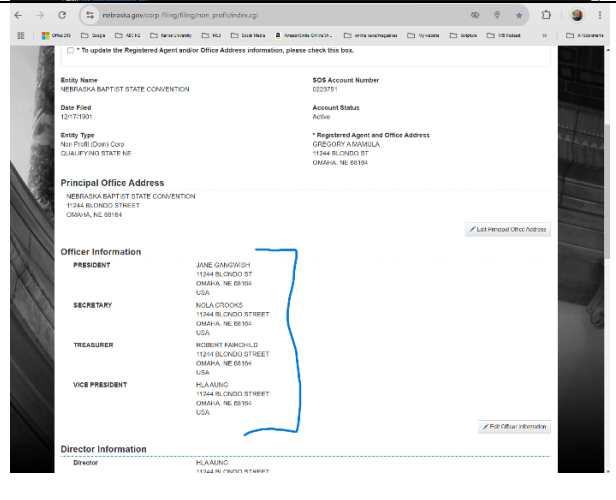
Step 5: Confirm additional information. All churches should choose the “has members” and “religious corporation” options.



Step 6: Update board member information.

Use the delete feature to remove board members who are no longer serving as board members.

Use the add officer feature to add new board members and titles. You can use the church address or their home address. Hit add after each new board member. Choose the continue button once all information is updated.
